(iii)	Desirable	<ul style="list-style-type: none"> <li>• Good Academic Record</li> <li>• Strong communication skills, both oral and written.</li> <li>• Analytical and presentation skills with ability to generate as well researched reports / papers.</li> <li>• Experience in collection, compilation and analysis of</li> </ul>

		statistical data, computer skills and preparation of Project Reports / Reviews / Notes / Briefs, etc.
(iv)	Duration & age limit	Candidates selected will be appointed on contract basis for an initial period of one year. This term can be extended upto maximum 5 years depending on the performance of the candidate and need of the Planning Commission. However, the maximum duration of the contract will not be extended beyond five years. The maximum age limit for Consultant shall be 65 years.
(v)	Fee	<b>For outside experts:</b> The consolidated fee shall range between Rs. 40,000/- and Rs. 70,000/- per month depending upon the qualification & work experience.  <b>For Retired Govt. Servants:</b> The amount of fee shall be decided in such a way that the fee plus pension drawn by them shall not exceed the last pay drawn. However, they will continue to draw pension and Dearness relief on pension during the period of their engagement as Consultant.
(vi)	Local Conveyance	The Consultant will be paid an additional amount of Rs. 3000/- per month as local conveyance.
